- 1 I, Craig M. Hoetger, declare as follows:
- 2 1. I am the Interim Executive Director of the Los Angeles County Civil Service Commission
- 3 (“Commission”), and I have served in that capacity since May 4, 2021.
- 4 2. As part of my duties as the Executive Director of the Commission, I am responsible for
- 5 managing the Commission, supervising staff, operating as the liaison between Commissioners, the
- 6 Board of Supervisors, parties and stakeholders.
- 7 3. The Commission is the appellate body with jurisdiction over certain employment
- 8 discrimination claims under the Los Angeles County Charter, Article IX, Sections 34 and 35.4 and
- 9 Civil Service Rule 4.01.
- 10 4. The Commission also maintains jurisdiction over County employee appeals for discharges
- 11 and reductions of permanent classified employees, pursuant to Los Angeles County Charter, Article
- 12 IX, Sections 34 and 35.6.
- 13 5. The Commission has the authority and jurisdiction to render a remedy in this case.
